### **The Opportunity**

*The Christmas Markets are a unique opportunity for some of Australia's best artisans to display and sell their Christmas wares within an iconic hub of South Bank Parklands. The Markets will be complimented by a program of entertainment located throughout the Parklands.*

### **Eligible Products**

*All products offered for sale should be unique, quality products and/or festive ware.*

*We are looking for a mix of traditional Christmas themed products, including decorations, gifts, cards, toys, clothing, jewellery, home wares and food products – all to fit a range of Christmas shopping budgets.*

*Entry into the Market will be undertaken on a competitive basis to ensure the market presents the best available variety and selection of products.*

***This year, the Xmas Market will be using marquees that have a clear PVC roof and a fairy light display in the roof frame. A white polyester ceiling will be also installed to minimise direct sunlight into the stall during the day. The overall effect created by a line of these lighted canopies is expected to create a spectacle for our night time visitors.***

### **Booking Dates**

*Please note that stall spaces are limited and you must book all 6 days.*



### **Stall Fees**

#### **Little Stanley Street 2.4m marquee:**

18 – 23 December \$780.00 (incl. GST)

#### **Little Stanley Street 4.8 X 2.4m marquee:**

18 – 23 December \$1,500.00 (incl. GST)

Double sites availability subject to prior approval from management only.

An additional \$20.00 on top of the total stall fee is required if you DO NOT have Public Liability Insurance.

### **Equipment**

*The Market supplies the following:*

*In Little Stanley Street: A set up 2.4m x 2.4m marquee*

*A single power point to the stall – maximum of 960 watts per stall only.*

*Walls – these will be supplied to stallholders who do not have their own.*

*All other equipment required including lights, tables, chairs, awnings etc. must be supplied by you. Note all electrical equipment used must have a current and valid 6 month test and tag on it.*
